on november 29 1864 over 150 native americans mostly women children and elderly were slaughtered in one of the most infamous cases of state sponsored violence in u s history kelman examines how generations of americans have struggled with the question of whether the nation s crimes as well as its achievements should be memorialized

winner of the labriola center american indian national book award one of the american west s bloodiest and least known massacres is searingly re created in this generation spanning history of native white intermarriage national book award winning histories such as the hemingses of monticello and slaves in the family have raised our awareness about america s intimately mixed black and white past award winning western historian andrew r graybill now sheds light on the overlooked interracial native white relationships critical in the development of the trans mississippi west in this multigenerational saga beginning in 1844 with the marriage of montana fur trader malcolm clarke and his piegan blackfeet bride coth co co na graybill traces the family from the mid nineteenth century when such mixed

marriages proliferated to the first half of the twentieth when clarke s children and grandchildren often encountered virulent prejudice at the center of graybill s history is the virtually unexamined 1870 marias massacre on a par with the more infamous slaughters at sand creek and wounded knee an episode set in motion by the murder of malcolm clarke and in which clarke s two sons rode with the second u s cavalry to kill their own blood relatives

references to the indian wars those conflicts that accompanied us continental expansion suffuse american military history from black hawk helicopters to the exclamation geronimo used by paratroopers jumping from airplanes words and images referring to indians have been indelibly linked with warfare in indian wars everywhere stefan aune shows how these resonances signal a deeper history one in which the indian wars function as a shadow doctrine that influences us military violence the united states formative acts of colonial violence persist in the actions imaginations and stories that have facilitated the spread of american empire from the savage wars of the nineteenth century to the counterinsurgencies of the global war on terror ranging across centuries and continents indian wars everywhere considers what it means for the conquest of native peoples to be deemed a success that can be used as a blueprint for modern warfare

during the nineteenth century white americans sought the cultural transformation and physical displacement of native people though this process was certainly a clash of rival economic systems and racial ideologies it was also a profound spiritual struggle the fight over indian country sparked religious crises among both natives and americans in the gods of indian country jennifer graber tells the story of the kiowa indians during anglo americans hundred year effort to seize their homeland like native people across the american west kiowas had known struggle and dislocation before but the forces bearing down on them soldiers missionaries and government officials were unrelenting with pressure mounting kiowas adapted their ritual practices in the hope that they could use sacred power to save their lands and community against the kiowas stood protestant and catholic leaders missionaries and reformers who hoped to remake indian country these activists saw themselves as the indians friends teachers and protectors they also asserted the primacy of white christian civilization and the need to transform the spiritual and material lives of native people when kiowas and other native people resisted their designs these christians supported policies that broke treaties and appropriated indian lands they argued that the gifts bestowed by christianity and civilization outweighed the pains that accompanied the denial of freedoms the destruction of communities and the theft of resources in order to secure indian country and control indigenous populations christian activists sanctified the economic and racial hierarchies of their day the gods of indian country tells a complex fascinating and ultimately heartbreaking tale of the struggle for the american west

one historian s journey to find the end of the civil war and along the way to expand our understanding of the nature of war itself and how societies struggle to draw the line between war and peace we set out on the james river march 25 1865 aboard the paddle steamboat river queen president lincoln is on his way to general grant s headquarters at city point virginia and he s decided he won t return to washington until he s witnessed or perhaps even orchestrated the end of the civil war now it turns out more than a century and a half later historians are still searching for that end was it april 9 at appomattox as conventional wisdom holds where lee surrendered to grant in wilmer mclean s parlor or was it ten weeks afterward in galveston where a federal commander proclaimed juneteenth the end of slavery or perhaps in august of 1866 when president andrew johnson simply declared the insurrection is at an end that the answer was elusive was baffling even to a historian of the

stature of michael vorenberg whose work served as a key source of steven spielberg s lincoln vorenberg was inspired to write this groundbreaking book finding its title in the peace lincoln hoped for but could not make before his assassination a peace that required not one but many endings as vorenberg reveals in these pages the most important of which came well more than a year after lincoln s untimely death to say how a war ends is to suggest how it should be remembered and vorenberg s search is not just for the civil war s endpoint but for its true nature and legacy so essential to the american identity it s also a quest in our age of forever wars to understand whether the united states s interminable conflicts of the current era have a precedent in the civil war and whether in a sense wars ever end at all or merely wax and wane

during the nineteenth century the u s military fought numerous battles against american indians these so called indian wars devastated indigenous populations and some of the conflicts stand out today as massacres as they involved violent attacks on often defenseless native communities including women and children although historians have written full length studies about each of these episodes massacring indians is the first to present them as part of a larger pattern of aggression perpetuated by heartless or inept military commanders in clear and accessible prose veteran historian roger l nichols examines ten significant massacres committed by u s army units against american indians the battles range geographically from alabama to montana and include such well known atrocities as sand creek washita and wounded knee nichols explores the unique circumstances of each event including its local context at the same time looking beyond the confusion and bloodshed of warfare he identifies elements common to all the massacres unforgettable details emerge in the course of his account inadequate training of u s soldiers overeagerness to punish indians an inflated desire for glory among individual officers and even careless mistakes resulting in attacks on the wrong village or band as the author chronicles the collective tragedy of the massacres he highlights the roles of well known frontier commanders ranging from andrew jackson to john chivington and george armstrong custer in many cases nichols explains it was lower ranking officers who bore the responsibility and blame for the massacres even though orders came from the higher ups during the nineteenth century and for years thereafter white settlers repeatedly used the term massacre to describe indian raids rather than the reverse they lacked the understanding to differentiate such raids indians defending their homeland against invasion from the aggressive decimation of peaceful indian villages by u s troops even today it may be tempting for some to view the massacres as exceptions to the norm by offering a broader synthesis of the attacks massacring indians uncovers a more disturbing truth that slaughtering innocent people was routine practice for u s troops and their leaders

custer s last stand remains one of the most iconic events in american history and culture had custer prevailed at the little bighhorn the victory would have been noteworthy at the moment worthy of a few newspaper headlines in defeat however tactically inconsequential in the larger conflict custer became legend in inventing custer the making of an american legend edward caudill and paul ashdown bridge the gap between the custer who lived and the one we ve immortalized and mythologized into legend while too many books about custer treat the civil war period only as a prelude to the little bighorn caudill and ashdown present him as a product of the civil war reconstruction era and the plains indian wars they explain how custer became mythic shaped by the press and changing sentiments toward american indians and show the many ways the myth has evolved and will continue to evolve as the united states continues to change

violence and public memory assesses the relationship between these two subjects by

examining their interconnections in varied case studies across the united states south america europe the middle east and africa those responsible for the violence discussed in this volume are varied and the political ideologies and structures range from apartheid to fascism to homophobia to military dictatorships but also democracy racism and state terrorism have played central roles in many of the case studies examined in this book and multiple chapters also engage with the recent rise of the black lives matter movement the sites and history represented in this volume address a range of issues including mass displacement genocide political repression forced disappearances massacres and slavery across the world there are preserved historic sites memorials and museums that mark places of significant violence and human rights abuse which organizations and activists have specifically worked to preserve and provide a place to face history and its continuing legacy today and chapters across this volume directly engage with the questions and issues that surround these sometimes controversial sites including photographs of many of the sites and events covered across the volume this is an important book for readers interested in the complex and often difficult history of the relationship between violence and the way it is publicly remembered

sinha not only has taken on this vast subject but has greatly expanded its definition both temporally and spatially she covers these difficult issues with remarkable skill and clarity s c gwynne new york times book review we are told that the present moment bears a strong resemblance to reconstruction the era after the civil war when the victorious north attempted to create an interracial democracy in the unrepentant south that effort failed and that failure serves as a warning today about violent backlash to the mere idea of black equality in the rise and fall of the second american republic acclaimed historian manisha sinha expands our view beyond the accepted temporal and spatial bounds of reconstruction which is customarily said to have begun in 1865 with the end of the war and to have come to a close when the corrupt bargain of 1877 put rutherford b hayes in the white house in exchange for the fall of the last southern reconstruction state governments sinha s startlingly original account opens in 1860 with the election of abraham lincoln that triggered the secession of the deep south states and take us all the way to 1920 and the ratification of the nineteenth amendment which granted women the right to vote and which sinha calls the last reconstruction amendment within this grand frame sinha narrates the rise and fall of what she calls the second american republic the reconstruction of the south a process driven by the alliance between the formerly enslaved at the grassroots and radical republicans in congress is central to her story but only part of it as she demonstrates the us army s conquest of indigenous nations in the west labor conflict in the north chinese exclusion women s suffrage and the establishment of an overseas american empire were all part of the same struggle between the forces of democracy and those of reaction the main concern of reconstruction was the plight of the formerly enslaved but its fall affected other groups as well women workers immigrants and native americans from the election of black legislators across the south in the late 1860s to the great railroad strike of 1877 to the colonial war in the philippines in the 1890s sinha narrates the major episodes of the era and introduces us to key individuals famous and otherwise who helped remake american democracy or whose actions spelled its doom a sweeping narrative that remakes our understanding of perhaps the most consequential period in american history the rise and fall of the second american republic shows how the great contest of that age is also the great contest of our age and serves as a necessary reminder of how young and fragile our democracy truly is

how a system of colonial trusteeship converted native wealth into settler capital from the earliest days of its founding the united states set its sights on native territory amid better known indian wars the federal government quietly built an empire by treaty offering payments to native peoples for their land routinely inadequate these payments were nonetheless pivotal because federal officials chose not to deliver them as a lump sum instead the government kept the bulk of payments owed to native nations under its own control as a trustee and made access to future installments contingent on native compliance

in vested interests emilie connolly describes how a system of fiduciary colonialism seized a continent from its original inhabitants and ironically furnished native peoples with financial resources that sustained their nations connolly documents two centuries of dispossession in the guise of fiduciary benevolence acting as both dispossessor and trustee the federal government invested native wealth in state bonds that financed banks canals and other infrastructural projects that enabled the country to expand further westward meanwhile native peoples protected the money they did receive for future generations investing it in their own institutions and mounting legal challenges to hold their trustees accountable still federal trusteeship placed tight constraints on native economies with the aim of containing native power forcing nations to endure through sheer resilience and ingenuity by chronicling the long history of native land dispossession through financial paternalism vested interests reveals the unequal dividends of colonialism in the united states
